

# US Visa Application

The US is one of the uppermost visited destinations in the entire world. And while a lot of us dream of visiting the US or organizing a vacation to states, it is very significant to know about the method for **US Visa**.



There are various types of visas that one can take for the US visit. If you wish to go on a business trip there is a separate kind of visa, whereas if you just want to visit for the purpose of tourism, then there is a distinct kind of visa.

Thus, it is very necessary for one to know about the visa type and conditions before applying for it. Let us take a look at 2 of the most relevant visa types for the US.

**1) Business Visa (B1)** – The B1 Visa is usually offered to individuals who are visiting for the purpose of business meetings, conferences, attending of scientific, professional or educational conventions, etc. This visa is frequently offered for a brief period of time in order to fulfill the necessity of work. **2) Tourist Visa (B2)** – This is the common popular Visa that is given to the majority of people for the purpose of tourism in the US. The B2 Visa is offered to people who are traveling for the goal of recreation in nature, tourism activities, visiting friends or relatives, medical treatments or activities, etc. This visa is usually offered for a longer period of time ranging from 1 year to 10 years, hence, the period of stay during one trip is a maximum of six months where multiple entries to the US are allowed.

## How to apply for US Visa?

Obtaining for the [USA Visa](#) is a long method. Hence, the US visa method is pretty straightforward. Before beginning your application, you will have to circumscribe the type of visa you need. After this, proceed as per the following -

1. Get the certificates you require to complete the application.
2. You will require to fill the NIV US Visa form online: DS-160 form
3. You should then continue to pay your US visa fees online.
4. Once this is done, submit your application. You will take a fee receipt, and DS-160 approval via your email.
5. Using the DS-160 application barcode, and the visa fee receipt number, proceed to schedule your US Visa appointment. This requires two appointments. The first one at a VAC (Visa Application Center) for the biometric submission, and the next at a US Embassy or Consulate-General for the visa interview.
6. Visit the VAC for your biometric first, along with the passport, appointment, and D-160 confirmation pages.
7. After the submission at VAC, you will then have to visit a US Embassy or Consulate for your interview, along with your supporting certificates, appointment confirmation letter, and VAC stamped D-160 confirmation page.



## Where to apply?

The applications for the US visa India have to be done online. Hence, for the appointments, you will have to visit a VAC, and an Embassy or Consulate in that order. For the biometric submission, you can go to any VACs situated across the nation. After that, for your visa interview, you can make an appointment and visit the US Embassy New Delhi address, or at any US Consulate-General at Chennai, Hyderabad, Kolkata, or Mumbai.
